## ENROLLMENT CONTRACT — SUMMER 2010

- A. Program Fees** – Payment of program fees is a condition of enrollment. Program fees will be due in full at the time of enrollment.
- Cancellations and Refunds** – For refund of fee, all cancellations must be in writing and received by May 15, 2010. Cancelled enrollment cannot be assumed until confirmed by the Summer Dance Program. After May 15, 2010 no refunds or rebates will be made for any reason, including, without limitation: absences, suspensions, dismissals or withdrawals.
- NSF Checks** – A fee of \$30.00 will be charged for all checks returned by the bank. Subsequent payment must be made by money order or cashier's check.
- B. Suspension and dismissal** – The Roeper Summer Dance Program has the right to suspend or dismiss any student as a result of his/her behavior or if, in the opinion of the Program administration, the interests of the students or Program would be best served by this action. Roeper is a drug-free and smoke-free environment.
- C. Waiver and Release** – In exchange for good and valuable consideration, I hereby release Roeper City and Country School, Inc. and its directors, officers, employees and agents from any and all liability, claims or damages, and do hereby waive any and all claims or actions on behalf of myself, my heirs, assigns or successors in interest (with the exception of willful and wanton behavior), which have arisen or may arise against the Roeper City and Country School, Inc. with respect to Roeper Summer Dance program for 2010 and my student's participation in the same.
