ENROLLMENT CONTRACT — SUMMER 2010

- A. Enrollment deposit** — The Enrollment Deposit of \$150.00 per session must be enclosed with this application and will be deducted from the total camp fee at the time of billing. The \$150.00 per session is nonrefundable after March 31, 2010. For refund of deposit, cancellation must be received in writing before March 31, 2010. It is the parent's responsibility to confirm receipt by the school of written notice of cancellation. There are no refunds or makeup days for absences except as indicated in the catalog. **After March 31, 2010 no refunds will be issued, and all unpaid fees shall be due and payable in the amounts and at the times designated in the contract.**
- B. Camp Fees** — Payment of camp fees, as stated above, is a condition of enrollment. Camp fees will be due in two equal installments as follows: Installment #1 due April 1, 2010 and Installment #2 due May 1, 2010. Late payments may jeopardize child's enrollment.
Cancellations and Refunds — Cancellation of enrollment should not be assumed until confirmed by the Camp. Refunds of deposit only are provided before March 31st and must be requested in writing. Refunds of camp fees are not provided after April 1st for any reason, including, without limitation: absences, suspensions, dismissals, withdrawals, or dissatisfaction with placement or program.
Extended Illnesses — In the case of extended illness confirmed in writing by a physician, camp fees will be refunded on a per-day basis beginning after the fourth day of absence.
NSF Checks — A fee of \$30.00 will be charged for all checks returned by the bank. Subsequent payment must be made by money order or cashier's check.
Cost of Collection — In the event the Camp incurs collection costs including, but not limited to, court fees and attorney fees, to collect sums due the Camp under this contract, I/we agree that such fees shall be payable to the Camp by me/us in addition to the other sums due the Camp under this contract.
- C. Conduct, suspension and dismissal** — The Camp, in its sole discretion, shall determine if the conduct of the student or parent warrants dismissal. Camp has the right to suspend or dismiss any camper as a result of his/her behavior or if, in the opinion of the Camp administration, the interests of the camper or Camp would be best served by such action. I/We agree that we and the camper will respect and be bound by the Camp's practices, policies, rules and regulations, as may be amended from time to time. I/We and the camper further agree not to engage in any conduct or activities that may be disruptive or detrimental to the administrative, educational or extracurricular environment at camp.
- D. Placement** — Roper Summer Day Camp has the right to determine each camper's group placement and the activities and service to be provided.
- E. Waiver and Release** — In exchange for good and valuable consideration, my child and I, as well as our heirs, successors and assigns, hereby waive and release any and all rights, claims and actions for any injuries, losses and damages of any nature my child or I may have against Roper City and Country School, Inc., its directors, officers, employees and agents which in any way arise out of or relate to my child's participation in Roper Summer Day Camp, including without limitation, any claims based on negligence.
