# ENROLLMENT CONTRACT — SUMMER 2010

- A. **Enrollment Deposit** — The Enrollment Deposit per session must be enclosed with this application and will be deducted from the total program fee at the time of billing. The per session deposit is nonrefundable after April 15, 2010. For refund of deposit, cancellation must be received in writing before April 15, 2010. It is the parents' responsibility to confirm receipt of written cancellation by the Summer Theatre. There are no refunds or make-up days for absences except as indicated in the brochure. **After April 15, 2010 no refunds will be issued, and all unpaid fees shall be due and payable in the amounts and at the times designated in the contract.**
- B. **Camp Fees** — Payment of program fees, as stated above, is a condition of enrollment. Program fees will be due in full by May 15, 2010. Late payments may jeopardize child's enrollment.  
**Cancellations and Refunds** — Cancellation of enrollment should not be assumed until confirmed by the Summer Theatre. Refunds of deposit only are provided before April 15<sup>th</sup> and must be requested in writing. Refunds of camp fees are not provided after April 15<sup>th</sup> for any reason, including, without limitation: absences, suspensions, dismissals, withdrawals, or dissatisfaction with placement or program.  
**Extended Illnesses** — In the case of extended illness confirmed in writing by a physician, camp fees will be refunded on a per-day basis beginning after the fourth day of absence.  
**NSF Checks** — A fee of \$30.00 will be charged for all checks returned by the bank. Subsequent payment must be made by money order or cashier's check.  
**Cost of Collection** — In the event the Summer Theatre incurs collection costs including, but not limited to, court fees and attorney fees, to collect sums due the Summer Theatre under this contract, I/we agree that such fees shall be payable to the Summer Theatre by me/us in addition to the other sums due the Summer Theatre under this contract.
- C. **Conduct, Suspension and Dismissal** — Roeper Summer Stock Theatre, in its sole discretion, shall determine if the conduct of the student or parent warrants dismissal. Roeper has the right to suspend or dismiss any student as a result of his/her behavior or if, in the opinion of Roeper administration, the interests of the student or Roeper would be best served by such action. I/We agree that we and the student will respect and be bound by the Theatre's practices, policies, rules and regulations, as may be amended from time to time. I/We and the student further agree not to engage in any conduct or activities that may be disruptive or detrimental to the administrative, educational or extracurricular environment at Roeper. Roeper is a smoke-free/drug-free environment.
- D. **Placement** — Roeper Summer Stock Theatre has the right to determine each student's group placement and the activities and services to be provided. Dissatisfaction with the placement of the student is not a basis for refund or rebate of any deposit or program fee paid and shall not discharge the obligation to continue to pay program fees at the times and in the amounts applicable for the student's placement. (The fees referred to are stated in the Roeper Summer Stock Theatre brochure.)
- E. **Waiver and Release** — In exchange for good and valuable consideration, my child and I, as well as our heirs, successors and assigns, hereby waive and release any and all rights, claims and actions for any injuries, losses and damages of any nature my child or I may have against Roeper City and Country School, Inc., its directors, officers, employees and agents which in any way arise out of or relate to my child's participation in Roeper Summer Day Camp, including without limitation, any claims based on negligence.
